- **MIDWEST HYBRID LEAGUE OVERTIME RULES:**

- A. When any of the 6A **VARSIITY GIRLS OR BOYS** schools above play any of 5A **VARSIITY GIRLS OR BOYS** schools above... **OR**...any two 5A **VARSIITY GIRLS OR BOYS** schools above play each other, two 10-minute overtime periods shall take place (these are **NOT** sudden death periods; the two 10-minute periods are played to completion).
 - B. If the score is still tied at the end of the two, 10-minute OT periods, the score will be recorded as tied. **NO TIE BREAKING PROCEDURE** (i.e., kicks from the penalty mark) **SHALL TAKE PLACE!**
 - C. When the three 6A schools above play each other, there are **NO** overtime procedures **OR** tie-breakers.

- **SKY-EM LEAGUE OVERTIME RULES:**

- A.** When any of the **VARSHITY BOYS** teams above play each other, two 10-minute overtime periods shall take place (these are **NOT** sudden death periods; the two 10-minute periods are played to completion). If the score is still tied at the end of the two, 10-minute OT periods, the score will be recorded as tied. **NO TIE BREAKING PROCEDURE** (i.e., kicks from the penalty mark) **SHALL TAKE PLACE!**
 - B.** When any of the **VARSHITY GIRLS** teams above play each other, two 10-minute overtime periods shall take place (these are **NOT** sudden death periods; the two 10-minute periods are played to completion). If the score is still tied at the end of the two, 10-minute OT periods, **kicks from the penalty spot** will be used to determine a winner.

3. 3A LEAGUE SCHOOL RULES:

- A.** Whenever the **VARSHITY Pleasant Hill Boys OR the Creswell Girls** teams play (regardless of their opponent), there are **NO OVERTIME PROCEDURES OR TIE BREAKERS.**
- B.** Whenever the **VARSHITY Creswell Boys** play any of the teams listed below, two 10-minute overtime periods shall take place (these are **NOT** sudden death periods; the two 10-minute periods are played to completion). If the score is still tied at the end of the two, 10-minute OT periods, **kicks from the penalty spot** will be used to determine a winner. Should they play another school **NOT** on the list below, there will be no overtime or tie-breaker procedures:
